

TOPIC:

Consider contract award for new LPISD Loafing Barn Project.

BACKGROUND:

La Porte ISD requested competitive sealed proposals from General Contractors for the construction of a new Loafing Barn located behind the recently constructed Grounds Building on Sens Road. Proposals were received, opened and read aloud on Wednesday, March 7, 2018 at 2:00 PM in accordance with the published specifications and pursuant to Texas Education Code §44.031(a)(5) and Texas Government Code Chapter 2269. Each proposal was evaluated based on the criteria set forth in the published specifications. A copy of the evaluation summary is attached.

Based on the evaluations of the proposals received, Tucon Construction, LLC appears to offer the proposal that is in the best interest of La Porte Independent School District.

Gallagher therefore recommends the La Porte ISD award a contract in the amount of \$552,000 to Tucon Construction, LLC for the construction of the new Loafing Barn.

Representatives of Gallagher and IBI Group will be present at the Board of Trustees Meeting to answer any questions.
